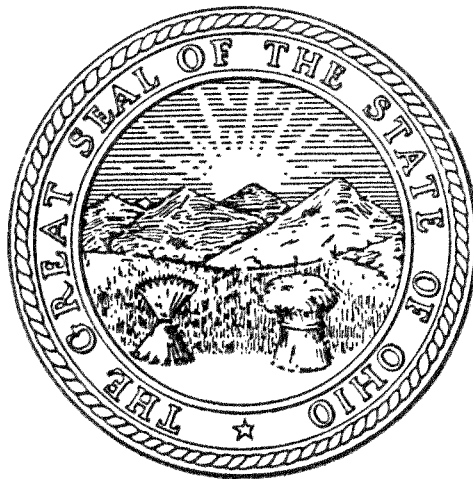

Gentlemen:


The Rocky River Municipal Court herewith submits it's
