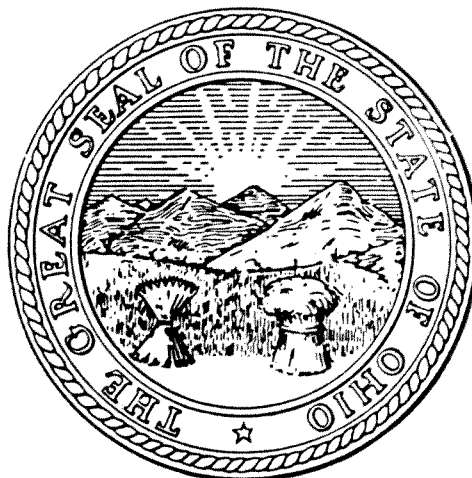

Dear Ladies and Gentlemen:

Pursuant to Section 1901.12 of the Ohio Revised Code, The Rocky River Municipal Court herewith submits it's 32nd Annual Report for the Year 1989.

The contents of this report are based on data assembled and tabulated by Ben K. Wright, Clerk of Courts and his Staff. Although this report is detailed with respect to statistics for political subdivisions within the Court's Jurisdiction, the following are noteworthy reflections:

- (1) The total funds received from all sources in the Year 1989 amounted to \$1,615,995.88 an increase of \$132,125.95 over 1988.
- (2) The total number of Traffic/Criminal cases filed in 1989 were 16,965. The statistical breakdown includes: 14,035 traffic, 855 DUI/BAC, 1,742 misdemeanors and 333 felonies which is an increase of 1,577 over 1988.
- (3) In 1989 Civil case filings in the Rocky River Municipal Court's Civil Division was 1,998 and total Civil court costs collected was \$106,588.38.
- (4) The total amount of Court costs disbursed to the City of Rocky River in 1989 from all sources amounted to \$676,634.12 an increase of \$66,959.79 over 1988.

In May 1987, the Court began implementation of computerizing the Criminal Branch of the Court. On January 1, 1988 the computerization of the Civil Branch was implemented. At the present time the Court is 100% computerized with the automation of the Assignment Commissioner's Department, Jury Selection Process and Supreme Court Reports being put on line in the past few months. The software programs that has been developed by the assistance of this Court's Staff has attracted considerable attention from many of Ohio's Municipal Courts. Presently, there are over twenty Municipal Courts using the software that was developed at Rocky River Municipal Court.

The Rocky River Municipal Court has been recognized for many years as having one of the most current dockets in the State of Ohio. This accomplishment is the reflection of the diligent and unselfish service of Judge Milton D. Holmes, Judge Maureen A. Gravens and the dedicated performance of an excellent Court Staff.

Sincere appreciations are extended to Mayor Earl Martin, the Rocky River Council and Police Officers and Official of the Court District for their continued help and support.
