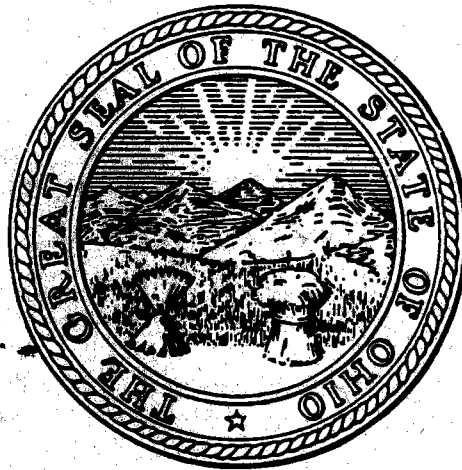

Thirty-Fourth Annual Report for the Year 1991.


The contents of this report are based on data assembled  
and tabulated by Ben K. Wright, Clerk of Courts and his Staff.  
Although this report is detailed with respect to statistics  
for political subdivisions within the court's jurisdiction,  
the following are noteworthy reflections:

- (1) The total funds received from all sources in the  
year 1991 amounted to \$1,985,575.29 an increase  
of \$111,660.09 over 1990.
- (2) The total number of Traffic/Criminal cases filed in  
1991 were 19,242. The statistical breakdown includes:  
15,414 traffic, 1,508 DUI/BAC, 1,850 misdemeanors  
and 470 felonies which is an increase of 1,528  
over 1990.
- (3) In 1991 Civil case filings in the Rocky River  
Municipal Court's Civil Division was 1,758 and  
total Civil court costs collected was \$112,585.42.
- (4) The total amount of court costs disbursed to the  
City of Rocky River in 1991 from all sources  
amounted to \$798,608.12 an increase of \$95,217.33  
over 1990.

I want to take this opportunity to thank the entire staff  
of the Rocky River Municipal Court for their outstanding and  
dedicated work. They all work hard to maintain a continuously  
current docket. The entire staff of the Rocky River Municipal  
Court is an asset to the communities in our court district.

As always, sincere gratitude is extended to the City of Rocky River's Mayor, Earl Martin, The Rocky River Council, Police Officers and officials of the Rocky River Court District for their continued assistance.
