Pursuant to Section 1901.12 of the Ohio Revised Code, The Rocky River Municipal Court herewith submits it's Thirty-Seventh Annual Report for the Year 1994.


The contents of this report are based on data assembled and tabulated by Ben K. Wright, Clerk of Courts and his Staff. Although this report is detailed with respect to statistics for political subdivisions within the court's jurisdiction, the following are noteworthy reflections:

- (1) The total funds received from all sources in the year 1994 amounted to \$2,409,894.89 a decrease of \$135,173.05 from 1993.
- (2) The total number of Traffic/Criminal cases filed in 1994 were 15,923. The statistical breakdown includes: 12,816 Traffic, 709 DUI/BAC, 2,026 Misdemeanors and 372 Felonies which is a decrease of 4,157 cases filed in 1993. This decrease is due to the 1994 compliance with the Ohio Supreme Court's rules of superintendence; whereas one defendant with multiple charges can only be counted as one case.
- (3) 1994 civil case filings in the Rocky River Municipal Court's Civil Division were 1,482 and total civil court costs collected was \$178,914.67.
- (4) The total amount of court costs disbursed to the City of Rocky River in 1994 from all sources amounted to \$926,650.25 which is a decrease of \$4,199.99 from 1993.

I want to take this opportunity to thank the entire staff of the Rocky River Municipal Court for their outstanding and dedicated work. They all work hard to maintain a continuously current docket. The entire staff of the Rocky River Municipal Court is an asset to the communities in our Court district.

As always, sincere gratitude is extended to the City of Rocky River's Mayor, Don Umerley, Rocky River City Council, Police Officers and officials of the Rocky River Court District for their continued assistance.
