Dear Ladies and Gentlemen:

As required by Section 1901.12 of the Ohio Revised Code, The Rocky River Municipal Court herewith submits it's thirty-ninth Annual Report for the year 1996.

The contents of this report are based on data assembled and tabulated by William E. Gareau, Clerk of Court and his staff. The following data are noteworthy for the year 1996.


1. The total funds received from all sources in the year 1996 amounted to \$2,650,185.79 an increase of \$42,585.28 over 1995.
2. The total number of traffic/criminal cases filed in 1996 were 14,425. The statistical breakdown includes: 11,464 traffic, 724 DUI/BAC, 1,833 misdemeanors and 404 felonies. The total traffic/criminal cases were down 937 cases from 1995.
3. The civil case filings in the Rocky River Municipal Court for 1996 were 1,472. Court costs collected on the civil cases amounted to \$154,346.94 a decrease of \$36,449.56 from 1995.
4. The total amount of court costs disbursed to the City of Rocky River in 1996 from all sources amounted to \$1,296,907.95 which is an increase of \$210,145.72 over 1995. I would point out however that \$150,109.00 of this increase is due to a computer fee established on 1/1/96. This fee was not collected in 1995. These funds are not available for operational costs.

During the year 1996 many plans were formulated to improve the operation of the Court. New telephone and computer systems were discussed and initial plans made to replace both of these outdated systems. Money collected in 1996 for the special computer fund will be used in 1997 to replace these two systems.

I want to thank the entire staff of the Clerks Office for their hard work and dedication. I would also like to thank Presiding/Administrative Judge Donna Congeni Fitzsimmons and Judge Maureen Adler Gravens and their staffs for their help and guidance during the year.

Finally, great appreciation is extended to Rocky River Mayor Don Umerley, Rocky River City Council, Police Officers, and Officials of the Rocky River Court District for their assistance.
