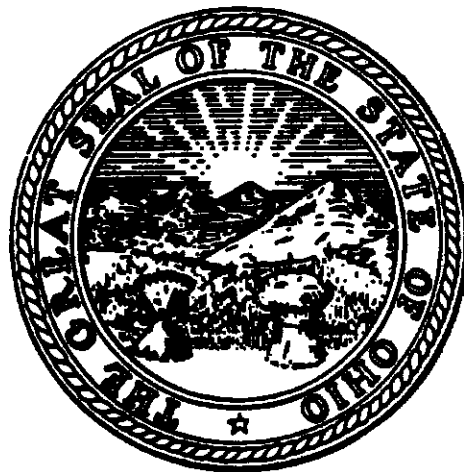

Dear Ladies and Gentlemen:

As required by Section 1901.14 of the Ohio Revised Code, the Rocky River Municipal Court herewith submits it's fortieth Annual Report with this 1997 edition.

The contents of this report are based on data assembled and tabulated by William E. Gareau, Clerk of Court, and his staff. The following data are noteworthy for the year 1997.


1. The total funds received from all sources in the year 1997 amounted to \$3,131,642.04 an increase of \$481,456.25 over 1996.
2. The total number of traffic/criminal cases filed in 1997 were 15,373. The statistical breakdown includes: 12,175 traffic, 668 DUI/BAC, 2,187 misdemeanors and 343 felonies. The total traffic/criminal cases were up 948 cases over 1996.
3. The civil case filings in the Rocky River Municipal Court for 1997 were 1,228. Court costs collected on the civil cases amounted to \$151,617.77 a decrease of \$2,729.17 from 1996.
4. The total amount of court costs disbursed to the City of Rocky River in 1997 from all sources amounted to \$1,622,891.89 which is an increase of \$325,472.94 over 1996. Of these funds, \$177,852.00 is a special computer fund set up by the Court on January 1, 1996. These funds are not available for use in operational costs.

During the year 1997, many meetings were held with Jim Mendel and Marlane Nibert of the Ohio Supreme Court, Office of Court Technology Services Division. After extensive investigation, proposals were prepared and bids received for a new computer system for the Court. We expect to award a contract in early 1998 and be fully functional by January 1999.

I want to thank the entire staff of the Clerk's Office for their hard work and dedication. I would also like to thank Presiding/Administrative Judge Donna Congeni Fitzsimmons and Judge Maureen Adler Gravens and their staffs for their help and guidance during the year.

Finally, great appreciation is extended to Rocky River Mayor Don Umerley, Rocky River City Council, Police Officers, and Officials of the Rocky River Court District for their assistance.

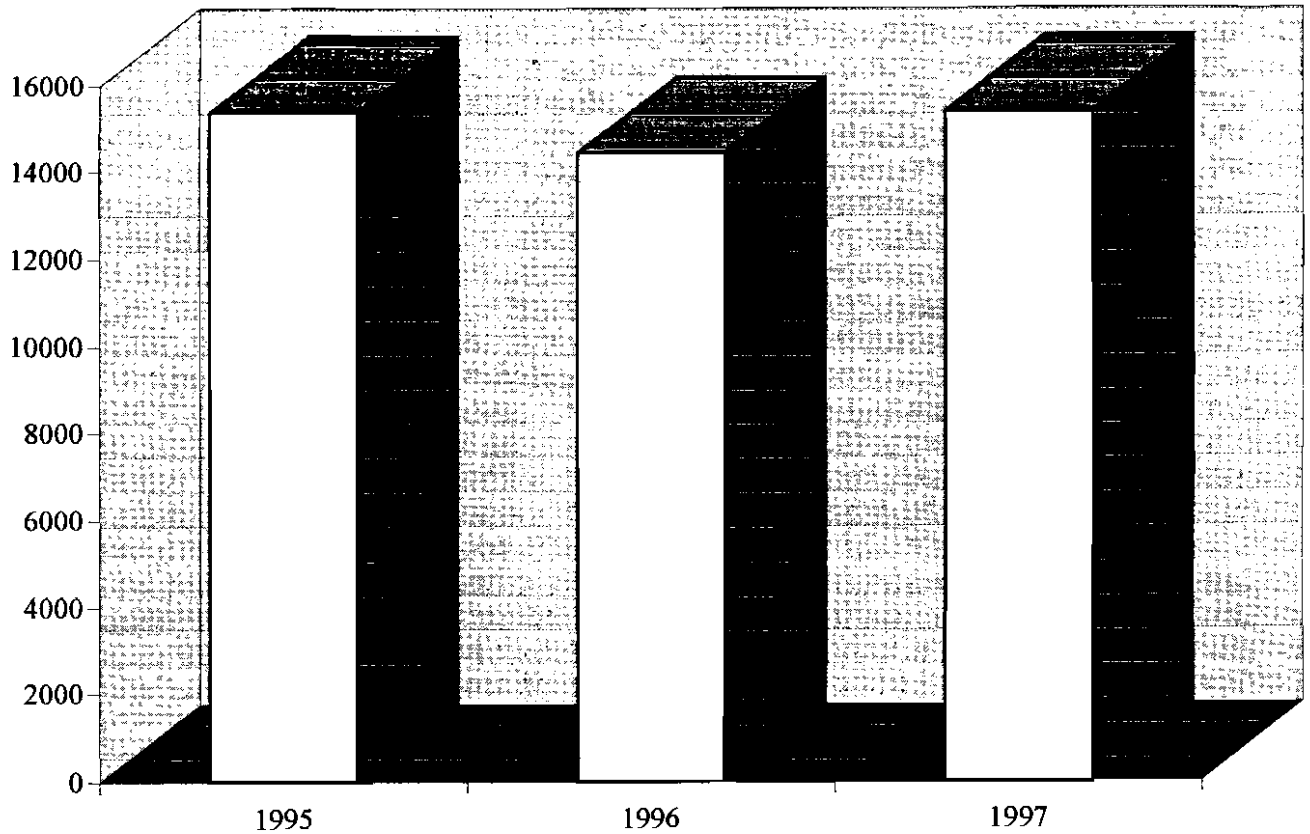

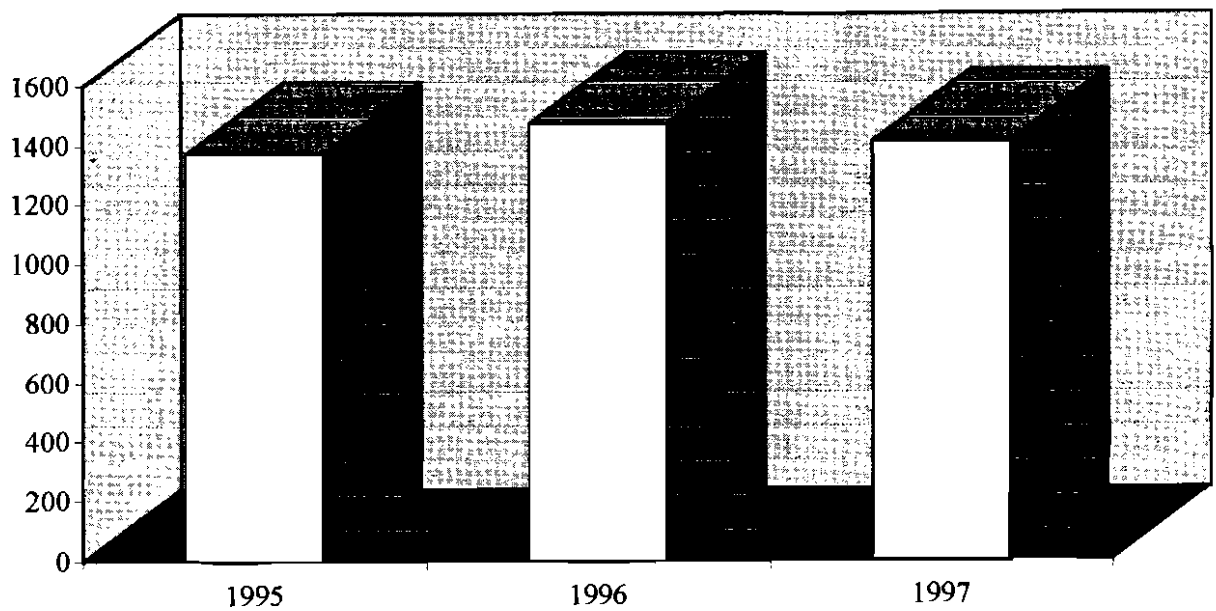

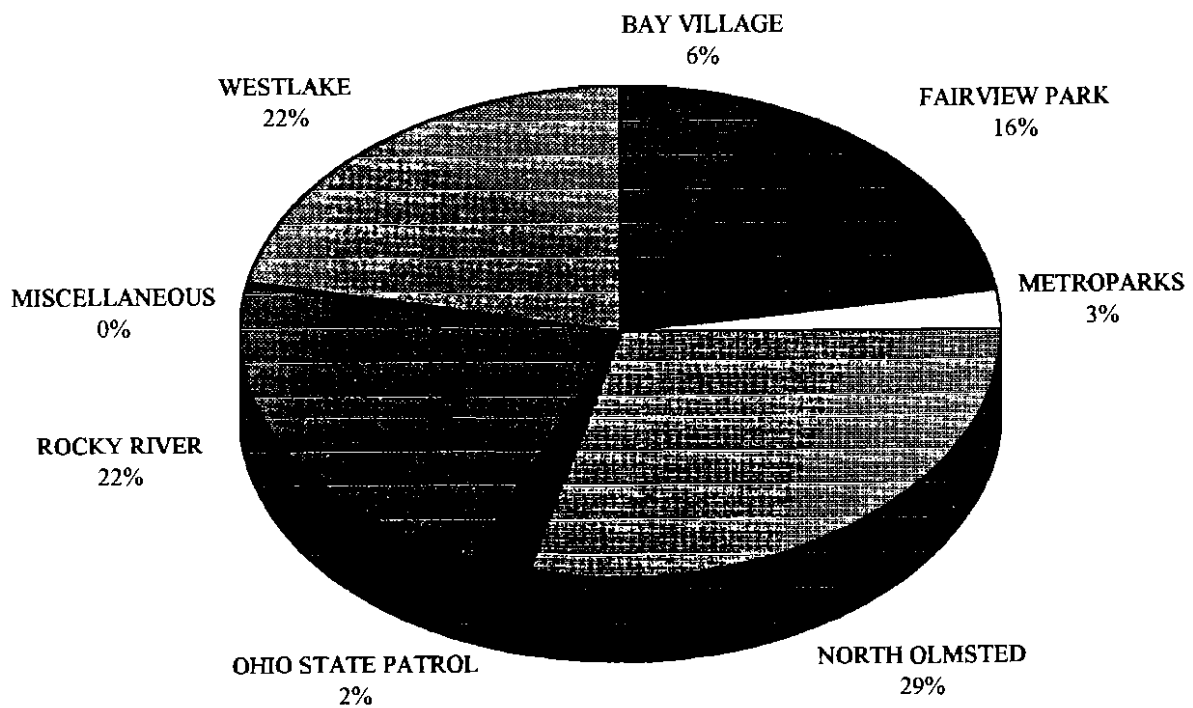
