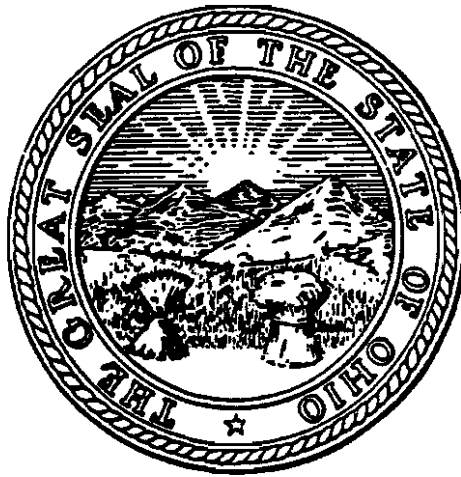

Dear Ladies and Gentlemen:

As required by Section 1901.14 of the Ohio Revised Code, the Rocky River Municipal Court herewith submits it's Annual Report for 1998.

The contents of this report are based on data assembled and tabulated by William E. Gareau, Clerk of Court, and his staff. The following data are noteworthy for the year 1998.

1. The total funds received from all sources in the year 1998 amounted to \$3,722,074.57, an increase of \$590,432.53 over 1997.
2. The total number of criminal/traffic cases filed in 1998 were 17,416. The statistical breakdown includes: 14,099 traffic, 701 DUI/BAC, 2,241 misdemeanors and 375 felonies. The total traffic/criminal case filings were up 2,043 cases over 1997.
3. The civil/small claims case filings in the Rocky River Municipal Court for 1998 were 2,141. The statistical breakdown includes 1,187 civil cases and 954 small claims cases. The total civil/small claims case filings were up 123 cases over 1997.
4. The total amount of court costs disbursed to the City of Rocky River in 1998 from all sources amounted to \$1,762,124.71, an increase of \$139,232.82 over 1997. Of these funds, \$195,577.00 were placed in a special computer fund set up by the Court on January 1, 1996, which are not available for use in operational costs.

During the year 1998, the City of Rocky River awarded a contract to Crawford Consulting, Inc., for a totally new computer system for the Court. The hardware and software will be replaced during 1999. The total cost for this system is a not to exceed fixed price of \$371,574.50. The Software Support Agreement is for a six year term, with payments spread out over that term for an estimated cost of \$133,060.00. We hope to be fully operational mid-summer of this year.

I want to thank the entire staff of the Clerk's Office for their hard work and dedication. I would also like to thank Presiding/Administrative Judge Donna Congeni Fitzsimmons, Judge Maureen Adler Gravens and their staffs for their help and guidance during the year.

Finally, great appreciation is extended to Rocky River Mayor Don Umerley, Rocky River City Council, Police Officers, and Officials of the Rocky River Court District for their assistance.

The Rocky River Municipal Court A Brief History

The Rocky River Municipal Court was created by the Ohio Legislature on June 17, 1957, by passage of House Bill 305. The Court was officially constituted and began to function on January 1, 1958. The jurisdiction of the Court was set within the limits of the municipalities of Bay Village, Westlake, Fairview Park, Parkview (now Fairview Park), North Olmsted, Rocky River and Riveredge Township (now Fairview Park and Cleveland) in Cuyahoga County.

Leonard S. Frost was the first Judge of the Rocky River Municipal Court. He was elected to a six year term in November, 1957, and assumed office in January, 1958. Judge Frost appointed Carl Acker as the Clerk of Court. In November, 1960, Judge Frost ran for and was elected a Judge of Probate Court of Cuyahoga County. Judge Frost resigned before finishing his term as Judge of the Rocky River Municipal Court. Governor Michael V. DiSalle appointed Milton D. Holmes to finish Judge Frost's term. Judge Holmes assumed office in February, 1961. Judge Holmes was elected to his own six year term in 1964 and every subsequent election until his retirement in 1992.

The US Census of 1970 established the Court District's population to be over 100,000 and a second Judgeship was created, as well as an elected Clerk of Court. William J. McCrone was elected to the second Judgeship and Ben K. Wright was elected Clerk of Court. Judge William J. McCrone served until his death in 1987. Ben K. Wright served until his retirement on December 31, 1995.

Governor Richard Celeste appointed Maureen Adler Gravens to replace Judge McCrone. Judge Gravens was sworn in on January 7, 1988. Judge Gravens has been elected and re-elected since her appointment. Judge Gravens was most recently re-elected in November, 1995, for the term January 1, 1996, to December 31, 2001. At the same election, William E. Gareau was elected Clerk of Court replacing the retiring Ben K. Wright. The term for Clerk is the same as Judge.

On September 10, 1992, William Huffman was appointed Judge by Governor George Voinovich to replace retiring Judge Holmes. In November, 1993, Donna Congeni Fitzsimmons was elected Judge of the Rocky River Municipal Court. On January 1, 1994, she was sworn in replacing Judge William Huffman. Judge Fitzsimmons current term ends December 31, 1999.

According to the 1959 Annual Report, which was the Court's second Annual Report, the Court took in \$38,084.27 in costs. The operating expenses for the same year were \$33,988.53. The excess costs collected were turned over to the City of Rocky River for a \$4,095.74 profit. It has been the general rule, over the years, that the Court has operated on less than the costs collected.

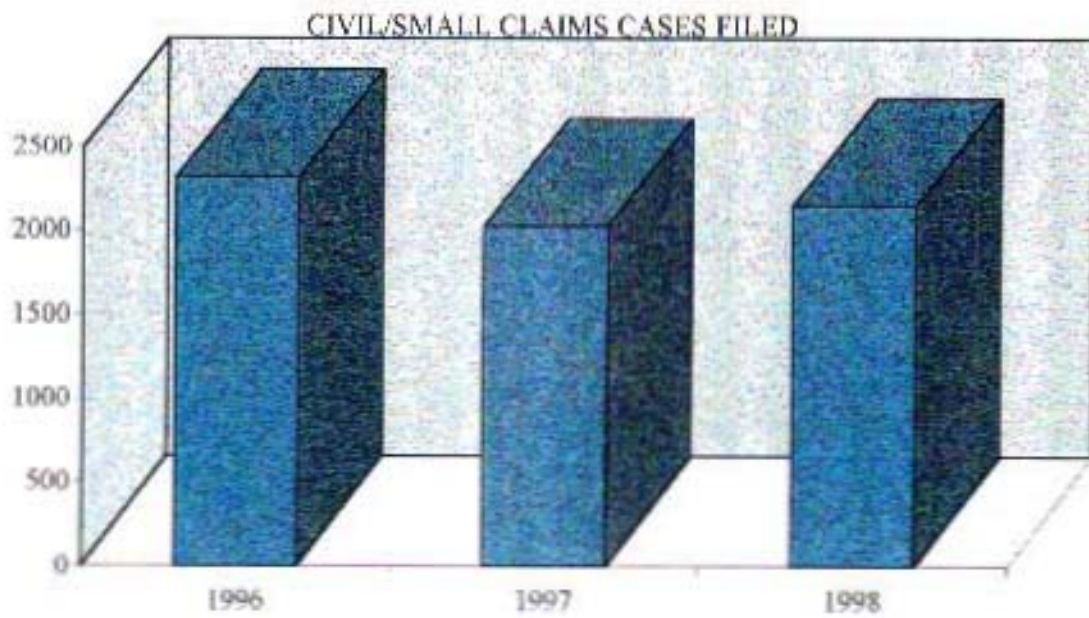
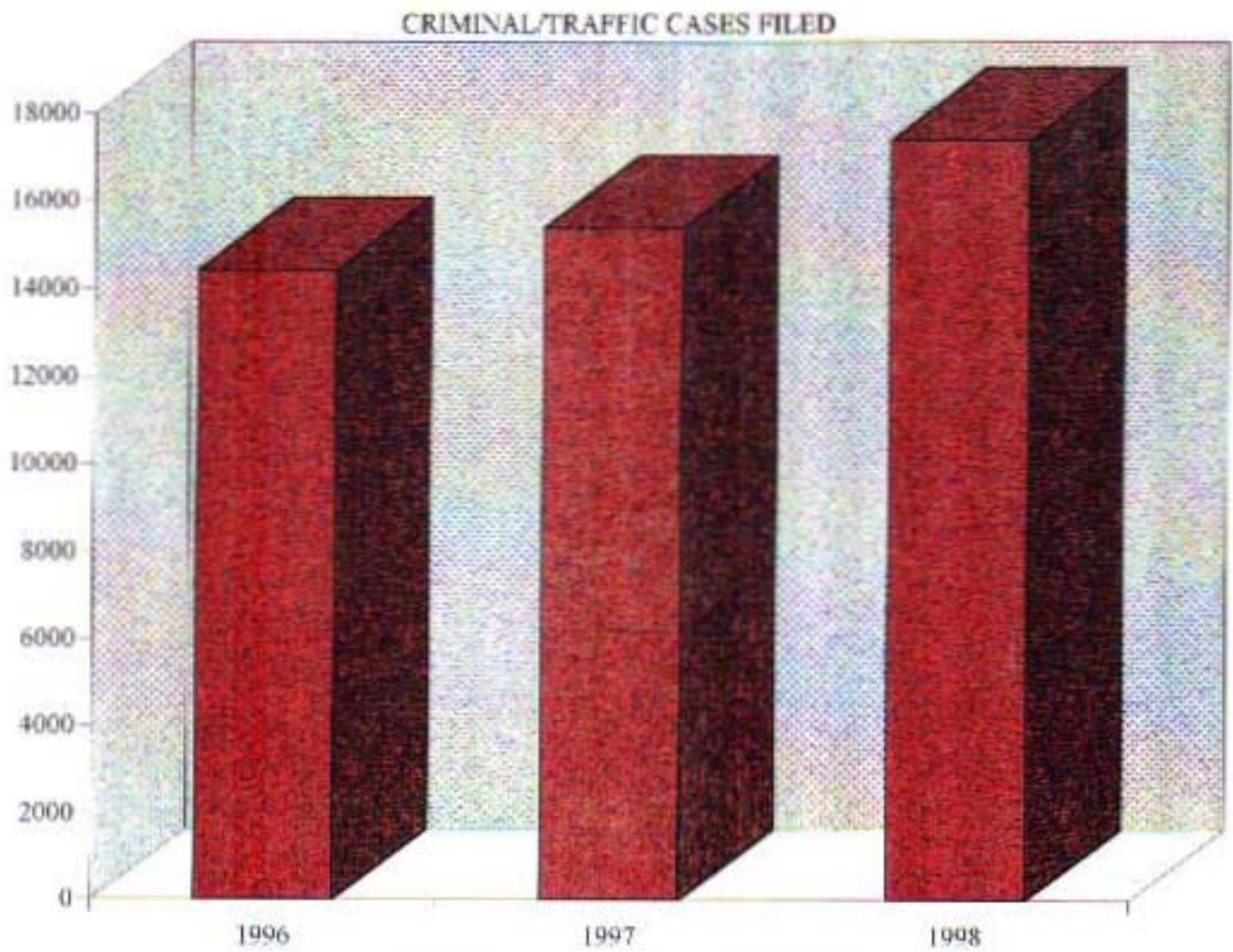

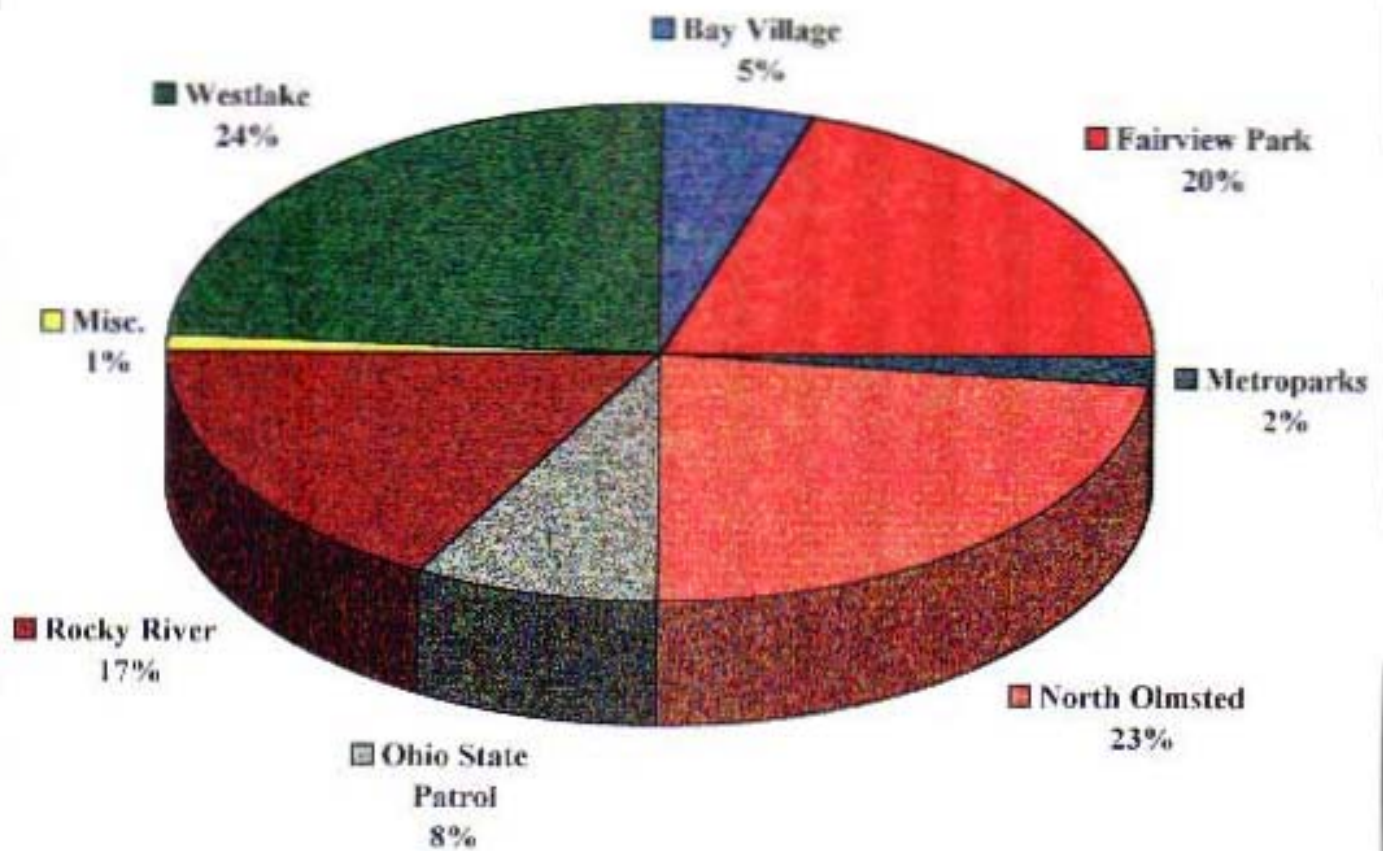

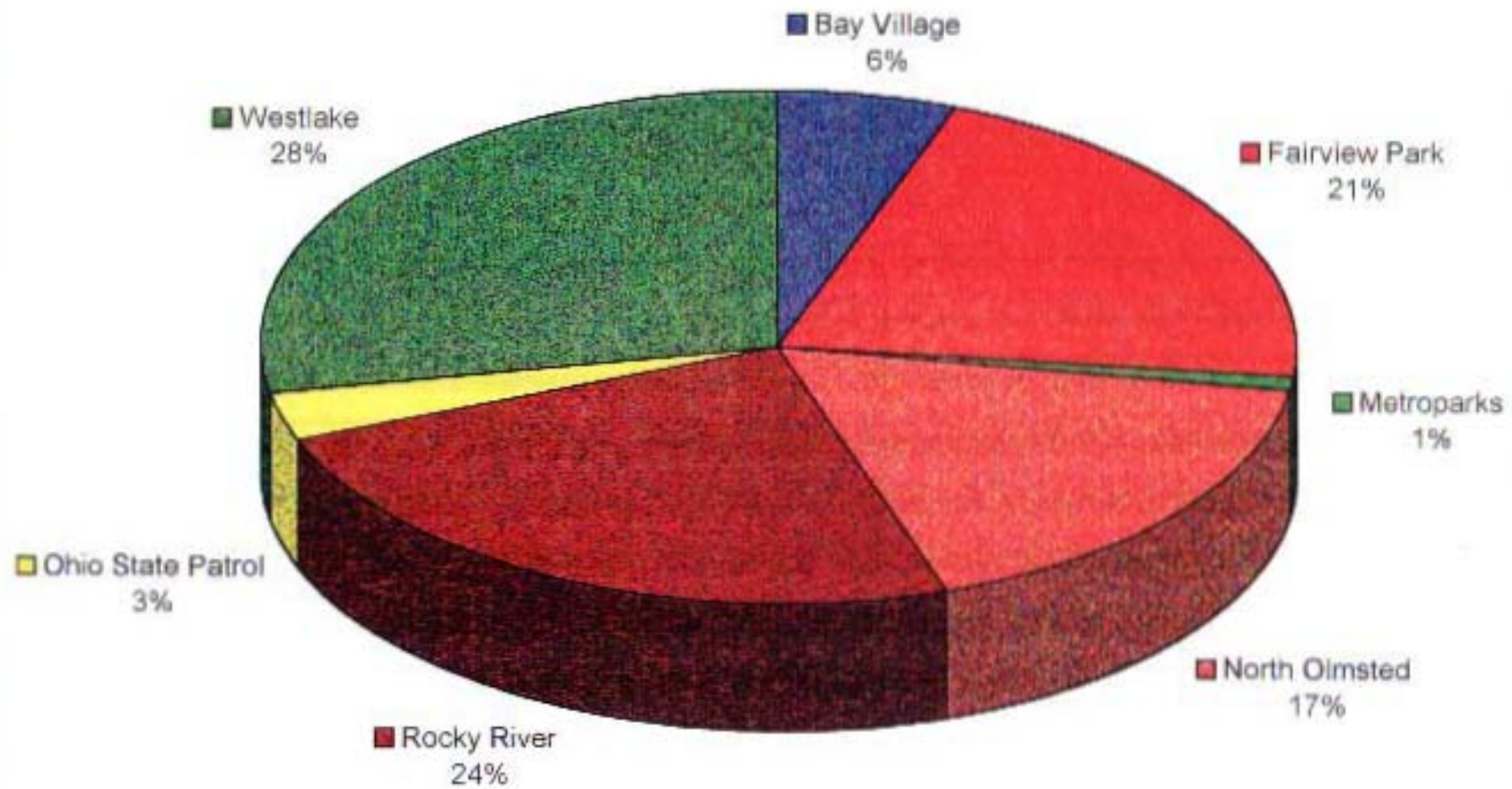
