Dear Ladies and Gentlemen:

As required by § 1901.14 of the Ohio Revised Code, the Rocky River Municipal Court herewith submits its Annual Report for 2004. The contents of this report are based on data assembled and tabulated by William E. Gareau, Clerk of Court, and his staff. The following data are noteworthy for the year 2004.

1. The total funds received from all sources in the year 2004 amounted to \$5,867,375.38 a decrease of \$126,604.08 from 2003.
2. The total number of criminal/traffic cases filed in 2004 was 28,825. The statistical breakdown includes 24,757 traffic, 751 DUI/BAC, 2550 misdemeanors, 353 felonies and 414 parking violations. The total criminal/traffic case filings were down 4,949 cases from 2003.
3. The civil/small claims case filings for 2004 were 2,629. The statistical breakdown includes 2,039 civil, 587 small claims and 3 rent escrow/trusteeship cases. The total civil case filings were up 121 cases over 2003.
4. The total amount of court costs disbursed to the City of Rocky River in 2004 from all sources amounted to \$2,766,701.21 a decrease of \$17,756.46 from 2003. Of these funds, \$361,332 was placed in a special Computer Fund set up by the Court on January 1, 1996. In addition, \$361,050 was placed in a Special Project Fund established by the Court on January 1, 1999. The money in these funds will be used to enhance the Court's computer system and pay off the debt of building the new court building. Also, \$90,450 was placed in the Court's probation funds. The monies in these special funds are not available for general operational costs.

The Court experienced a 15% decrease in criminal/traffic cases and a 5% increase in civil cases during 2004. Civil cases have risen for the past four years. The Court has no control over the number of criminal/traffic or civil cases filed each year.

We have enhanced our WEB site this past year, www.rrcourt.net, by accepting waiver payments over the Internet. Eventually we will accept filings (e-filing) which will save time for those wishing to use this service. Presently, the site allows public access to Court records back to 1987. In the future, we will be connected to the Ohio Courts Network (in the planning stages) which will allow all Ohio courts to communicate with each other as well as the BMV, prosecutors, and probation agencies.

I want to thank the staff of the Clerk's Office for their hard work and dedication during the year. Special thanks are given to Chief Deputy Clerk Deborah Comery who was given responsibility for compiling this report. I would also like to thank Presiding/Administrative Judge Maureen Adler Gravens and Judge Donna Congeni Fitzsimmons, and their staffs for their help and guidance during the year. Finally, appreciation is extended to Rocky River Mayor William Knoble, Rocky River City Council, Police Officers, and Officials of the Rocky River Court District for their assistance.

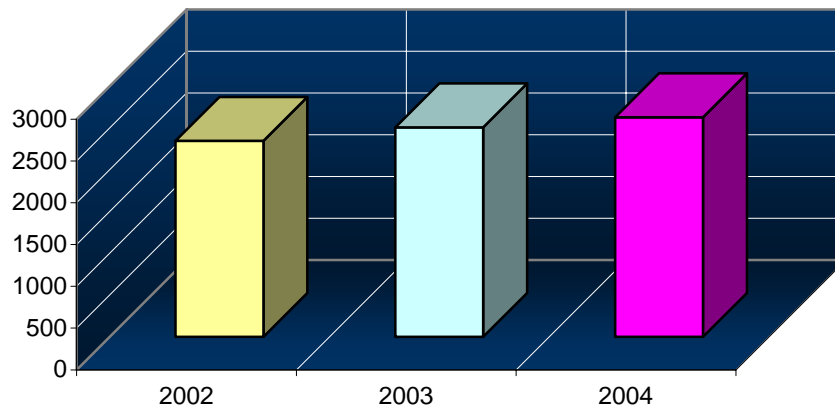

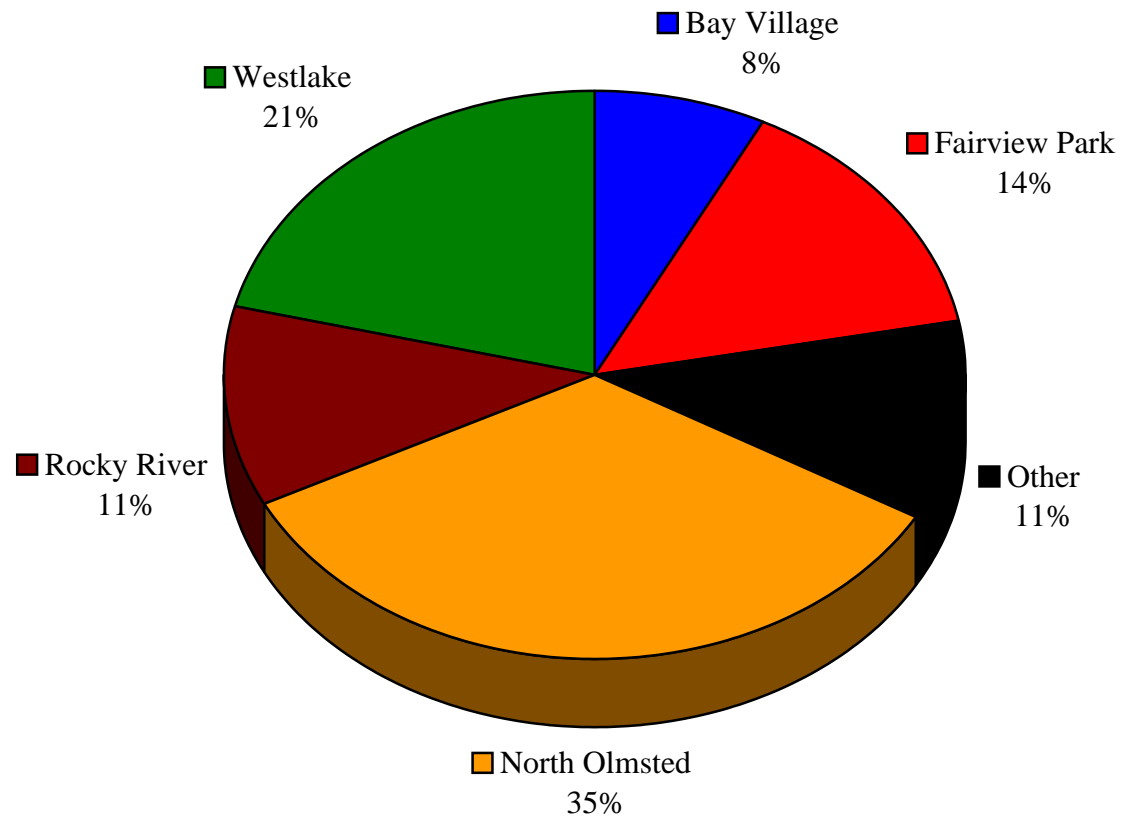

COMMUNITY CONTROL DEPARTMENT OVERVIEW

The Rocky River Municipal Court Community Control Department utilizes a variety of different activities, programs and services to achieve optimal results during supervision. In 2004, the Rocky River Community Control Department referred defendants to alcohol and drug treatment, half-way and three-quarter way houses, alcohol and other drug early intervention programs, Alcoholics Anonymous and other 12-step support programs. Our goal is to match program services with the type and level of client need.

Additionally, the Community Control Department also refers clients to local domestic violence and batterers' treatment programs. Referrals are also made to the Court's designated victim advocate. Community Control Officers conduct victim impact statements as part of the Pre-Sentence Investigation. When appropriate, defendants may be referred to anger management.

The Community Control Department refers to numerous state certified Driver Intervention Programs. Most O.V.I. offenders are mandated to some intervention program as part of their sentence. In addition to impaired drivers programs, the Department utilizes SCRAM, a thermal alcohol sensor worn on the offender's ankle, that is a continuous alcohol monitoring system. Total SCRAM referrals in 2004 were 10. A total of 535 screens for alcohol and drugs were conducted in 2004. The results of the screens were 383 negative screens (72%) and 152 positive screens (28 %).

The Court utilizes a number of state certified home detention providers. Electronically Monitored House Arrest (or Home Detention) occurs regularly as part of a defendant's sentence. Electronically monitored house arrest referrals for 2004 were 53. For O.V.I. defendants, the ignition interlock can be mandated as part of driving privileges. Ignition interlock referrals for 2004 were 113.

The Community Control Department refers defendants to multiple community and private mental health providers in addition to individual counselors. The Rocky River Municipal Court also participates in the Mental Health Liaison Byrne Foundation Grant.

The Department supports the defendant's completion of a high school equivalence diploma by passing the General Education Development Test (GED), and refers them to vocational programs.

Some of the programs utilized by the Department and a brief description follow:

Rocky River Municipal Court Young Adult Alcohol Diversion Program – The Young Adult Diversion Program provides a three-prong approach, including a short period of supervision, education about alcohol and other drug use, and community work service. The goal of the program is to assist the young adults in changing the behavior that brought them before the Court and to prevent or intervene upon alcohol and other drug issues. In exchange for compliance with all the requirements, the case will be dismissed.

Theft Intervention Program – Assessment Consultants’ Theft Intervention Program (TIP) is a five-week course designed for defendants with a theft charge. TIP is an all-encompassing program that places its focus on education and prevention in a therapeutic atmosphere.

2004 Combined Referrals: 49

Think About It Lecture Series (TAI) – TAI is a six-week alcohol and other drug lecture program that focuses on decreasing recidivism of O.V.I. offenses. The lecture series focuses on recognizing options while overcoming obstacles. Education increases understanding and can prevent alcohol and other drug abuse and problems associated with it. Most of all, the TAI Lecture Series teaches participants how alcohol and other drug abuse affects families, friends, and the community.

2004 Combined Referrals: 100

Mental Health Liaison Project, Byrne Grant – The Cuyahoga County Community Mental Health Board was awarded a Byrne Memorial Grant in 2002 to implement a countywide Mental Health Court Liaison Project. Recovery Resources has been designated as a mental health provider for this project. Rocky River Municipal Court has been one of five municipal courts involved in this project. The Grant has a renewal date of 2006.

The project is designed to ensure that severely mentally ill persons, those with psychotic or mood disorders charged with misdemeanor offenses in Cuyahoga County’s municipal courts, will be identified, screened and linked to mental health services in the community. The primary goal is to decrease the number of mentally ill persons processed through the judicial system by linking them to appropriate services.

2004 Combined Referrals: 58

Cuyahoga County Jail Reduction Program – The Rocky River Municipal Court refers eligible inmates, sentenced to the County Jail for sentences exceeding 30 days, to programs that may offer more appropriate sentence/sanction. These include electronic monitoring (home detention), substance abuse, or mental health treatment.
