

Dear Ladies and Gentlemen:

As required by Ohio Revised Code §1901.14, the Rocky River Municipal Court herewith submits its Annual Report for 2008. The contents of this report are based on data assembled and tabulated by Clerk of Court Deborah F. Comery and Court Staff. The following data is noteworthy for the year 2008:

- 1. The total receipts from all sources in 2008 amounted to \$6,876,879.16 of which \$2,066,036.16 was received for operational expenses. Since 1997, this Court has operated within its operational income.
- 2. There were 25,258 cases filed in criminal/traffic consisting of 21,387 traffic, 612 OVI/BAC, 2,549 misdemeanors, 354 felonies and 356 parking violations. Criminal/traffic case filings were up 480 cases from 2007.
- 3. There were 4,582 cases filed in civil and small claims consisting of 2,808 civil, 1,766 small claims and 8 rent escrow/trusteeship cases. The total civil case filings were up 1,374 cases over 2007.
- 4. The total amount of court costs disbursed to the City of Rocky River from all sources was \$3,147,595.37, an increase of \$378,354.88 over 2007. Of these monies, \$317,398.00 was placed in the Computer Fund set up by the Court on January 1, 1996, and \$587,902.15 was placed in the Special Projects Fund established by the Court on January 1, 1999. These funds are used to operate and enhance the Court's computer system and continue to pay off the building debt of the Courthouse (occupied in 2003). Also, \$149,274.52 was placed in the Court's Probation Services Fund, \$22,110.00 was placed in the Court's Mediation Fund, and \$3,985.00 was placed in the Court's Indigent Driver's Interlock and Alcohol Monitoring Fund. The monies in these special funds are not available for basic operational costs.

The court experienced a 1% increase in criminal/traffic cases and a 42% increase in civil/small claims cases during 2008. Civil/small claims cases have risen steadily for the past eight years with a significant increase in 2008. The court has no control over the number of criminal/traffic or civil/small claims cases filed each year.

The Court's website, www.rrcourt.net, continues to grow. E-Payments, Public Records Access, weekly Court Dockets, Local Rules, Jury Service information, Probation information, Annual Reports, and current court costs are among the many items found on our website. Since 2003, the website has accepted E-Payments primarily for those defendants who are allowed to waive their traffic ticket. 2008 saw 6,107 transactions, up 9% from 2007. All Court documents, both current and historical, continue to be imaged and are available for viewing on the website. E-Filing (initially for civil cases only) is now on the fast-track with a tentative rollout date of June, 2009. 2008 saw the automation of our ongoing E-Certified project in conjunction with the United States Postal Service, Pitney Bowes, Inc., and our case management software provider, CourtView Justice Solutions. Visitors to a case file can now track the progress of all E-Certified mail pieces as well as view the digital signature of the receiver.

I want to thank the staff of the Clerk's Office for their amazing work and dedication during the year. I would also like to thank Presiding/Administrative Judge Brian F. Hagan and Judge Donna Congeni Fitzsimmons, along with their staffs for their help and guidance during the year. Grateful appreciation is also extended to Rocky River Mayor Pamela E. Bobst, Rocky River City Council, and all the Jurisdictional Police Officers and Officials of the Rocky River Court District for their assistance.







COMMUNITY CONTROL DEPARTMENT OVERVIEW PROBATION – 2008

The Rocky River Municipal Court Community Control Department provides a variety of service to the court and the community. In 2008, the court instituted the Selective, Theft and Driving Under Suspension Diversion Programs, which are supervised through the Community Control Department. The Department provides assistance to offenders and diversion participants by obtaining services including community mental health, substance abuse, counseling and intervention programs. The Community Control Department monitors the offenders to reduce crime and protect the public.

2008 Diversion Programs

Young Adult Alcohol Diversion Program

The Rocky River Municipal Court Young Adult Alcohol Diversion Program provides a short period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders are required to complete an alcohol education program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.

Theft Diversion Program

The Rocky River Municipal Court Theft Diversion Program provides a six-month period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders are to complete a five-week Theft Intervention Program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.
