Dear Ladies and Gentlemen:

As required by ORC §1901.14, the Annual Report for 2010 is hereby submitted by the Rocky River Municipal Court. The contents of this report are based on data assembled and tabulated by Clerk of Court Deborah F. Comery and Court Staff. The following data is noteworthy for the year 2010:

- There were 23,574 cases filed in criminal/traffic consisting of 19,896 traffic, 532 OVI/BAC, 2,386 misdemeanors, 196 felonies and 564 parking violations. Criminal/traffic case filings were down a mere 18 cases from 2009.
- 2. There were 3,106 cases filed in civil and small claims consisting of 2,366 civil, 735 small claims and 5 rent escrow / trusteeship cases. The total civil case filings were down 781 cases from 2009.
- The total amount of court costs disbursed to the City of Rocky River from all sources was \$3,079,768.05. monies, \$2,008,029.18 was placed in Rocky River's revenue line items covering the Court's operational revenue. \$291,704.50 was placed in the Computer Fund set up by the Court on January 1, 1996, and \$547,166.50 was placed in the Special Projects Fund established by the Court on January 1, 1999. These funds are used to operate and enhance the Court's computer system and continue to pay off the building debt of the Courthouse (occupied in 2003). Also, \$187,936.37 was placed in the Court's Probation Services Fund, \$15,205.00 was placed in the Court's Mediation Fund, and \$29,726.50 was placed in the Court's Indigent Drivers Alcohol Treatment Fund. The monies in these special funds are not available for operational costs.
- Due to Rocky River Municipal Court's jurisdictional participation in the new Cuyahoga County Early Processing Pilot Program this year, the number of felonies filed this year has dropped dramatically. In general, felonies are now filed with RRMC in order to procure an arrest warrant. As soon as that warrant is executed, the case is immediately submitted to the Court of Common Pleas and dismissed at RRMC.

The court experienced a less than 1% decrease in criminal / traffic cases and a 20% decrease in civil / small claims cases during 2010. The court has no control over the number of criminal/traffic or civil/small claims cases filed each year.

The court's website, www.rrcourt.net, continues to grow. E-payments, public records access, weekly court dockets, local court rules, jury service information, probation information, annual reports, and current court costs are among the many items found on our website. Since 2003, the website has accepted E-payments primarily for those defendants who are allowed to waive their traffic ticket or who choose to pay their fines and costs after their case has been adjudicated. All court documents, both current and historical, continue to be imaged and are available for viewing on the website. RRMC's Civil E-filing pilot began in 2010 and has very successful. We've received positive feedback from the participating attorneys' offices. We continue utilizing the E-certified mail process with continuing success. All service information from certified mailings is now downloaded automatically to the case docket.. Visitors to a case file can track, in almost real time, the progress of all E-certified mail pieces as well as view the digital signature of the receiver.

I want to thank the staff of the Clerk's Office for their amazing work and dedication during the year. I would also like to thank Administrative / Presiding Judge Brian F. Hagan and Judge Donna Congeni Fitzsimmons, along with their staffs for their help and guidance during the year. Grateful appreciation is also extended to Rocky River Mayor Pamela E. Bobst, Rocky River City Council, and all the Jurisdictional Police Officers and Officials of the Rocky River Court District for their assistance.


The *Indigent Drivers Alcohol Treatment Fund/ Indigent Drivers Interlock and Monitoring Fund* provides treatment and monitoring services for persons arrested while operating a vehicle under the influence. The funds come from fees and fines collected as legislated by the Ohio General Assembly. The Rocky River Municipal Court utilizes these funds to assist OVI offenders who are unable to afford substance abuse treatment and alcohol monitoring. In 2010 the Rocky River Municipal Court spent \$25,234.84 for treatment and \$8,012.00 for monitoring.



The Jail Reduction Program was established to reduce jail crowding and link offenders that have substance abuse problems with treatment.

Typical reason for this is because of warrants or violent criminal histories.
