Dear Ladies and Gentlemen:

As required by ORC §1901.14, the Annual Report for 2012 is hereby submitted by the Rocky River Municipal Court. The contents of this report are based on data assembled and tabulated by Clerk of Court Deborah F. Comery and Court Staff. The following data is noteworthy for the year 2012:

1. There were 25,175 cases filed in criminal/traffic consisting of 21,018 traffic, 619 OVI/BAC, 2,906 misdemeanors, 167 felonies and 465 parking violations. Criminal/traffic case filings increased by 1,355 cases from 2011.
2. There were 2,751 cases filed in civil and small claims consisting of 2,153 civil, 591 small claims and 7 rent escrow / trusteeship cases. The total civil case filings decreased by 20 cases from 2011.
3. The total amount of court costs disbursed to the City of Rocky River from all sources was \$3,258,524.26. Of these monies, \$2,107,566.16 was designated as the Court's operational revenue. \$301,294.20 was placed in the Computer Fund to operate and enhance the Court's computer system. \$567,598.65 was placed in the Special Projects Fund to continue to pay down the principal and interest debt of the Courthouse structure as well as expensing the salary and benefits of the Court's Magistrates. Also, \$236,300.15 was placed in the Court's Probation Services Fund to assist in the operations of the Community Control Department. \$13,595.00 was placed in the Court's Mediation Fund to operate the Court's Mediation Program. \$45,448.10 was placed in the Court's Indigent Drivers Alcohol Treatment (IDAT) Fund to cover indigent offenders' alcohol assessment and treatment. \$23,676.30 was placed in the Court's Indigent Drivers Interlock and Alcohol Monitoring (IDIAM) Fund to cover the monitoring of indigent offenders. A portion of the monies placed in the IDAT Fund and all of the IDIAM Fund were derived from fine disbursements as mandated by the Ohio Revised Code.

The court experienced a 6% increase in criminal / traffic cases and a 1% decrease in civil / small claims cases during 2012. The court has no control over the number of criminal / traffic or civil / small claims cases filed each year.

We are continuing our effort to become a completely paperless court by instituting an email delivery system for all Court documents. Many of the Court's documents that were previously mailed to parties in court cases are now being emailed enabling the court to marketedly reduce the ever increasing postage expense, reduce paper usage court-wide and lessen labor requirements due to less handling and processing of paper documents.

The Court has enhanced its video arraignment capabilities to include any video equipped facility within the State of Ohio. Since RRMC began video arraignments from the jurisdictional police departments, the need to transport a defendant has been eliminated. Safety and health benefits along with officer time and travel expenses to bring a defendant to Court are realized.

Since 2003, the court's website, www.rrcourt.net, has become an integral part of the Court's public outreach. **eFiling**, **ePayments**, waiver information, public records access, weekly court dockets, local court rules, jury service information, probation information, and annual reports are among the many items found on our website. Our website continues to accept **ePayments** primarily for those defendants who are allowed to waive their traffic ticket or who choose to pay their fines and costs after their case has been adjudicated. All court documents, both current and historical, continue to be imaged and are available for viewing on the website.

RRMC's **eFiling** pilot began in 2010 and continues to grow in usage and has proven very successful. We've received positive feedback from the participating attorneys' offices.


We continue utilizing the **eCertified** mail process with continued success. All service information from certified mailings, including recipient signatures, is downloaded automatically to the individual case docket. Visitors to a case file can track, in almost real time, the progress of all **eCertified** mail pieces.

On December 14, 2012, the Clerk's Office began participation in a pilot program through the Cuyahoga County Probate Court's Marriage License Bureau. One day a month, residents of Cuyahoga County may apply for a marriage license at Rocky River Municipal Court without having to travel to the downtown Court facility. If the pilot program is deemed successful, the days per month will be increased.

A major change to the Rocky River Municipal Court was decided upon in 2012 with the creation of the City of North Olmsted's Mayor's Court that opened for business on January 1, 2013. With that decision, a major transformation took place at RRMC in the second half of 2012. Financial analyses were computed to determine the monetary impact the Mayor's Court would create. With that information, as well as 2013 case load predictions, the Court's staffing needs were reviewed. The required staffing reductions were then set in place to insure Rocky River Municipal Court's ability to continue to operate in the black as it has for the last 16 years.

I want to thank the staff of the Clerk's Office for their amazing work and dedication during the year. I would also like to thank Administrative / Presiding Judge Brian F. Hagan and Judge Donna Congeni Fitzsimmons and their staffs for their help and guidance during the year. Grateful appreciation is also extended to Rocky River Mayor Pamela E. Bobst, Rocky River City Council, and all the Jurisdictional Police Officers and Officials of the Rocky River Court District for their assistance.

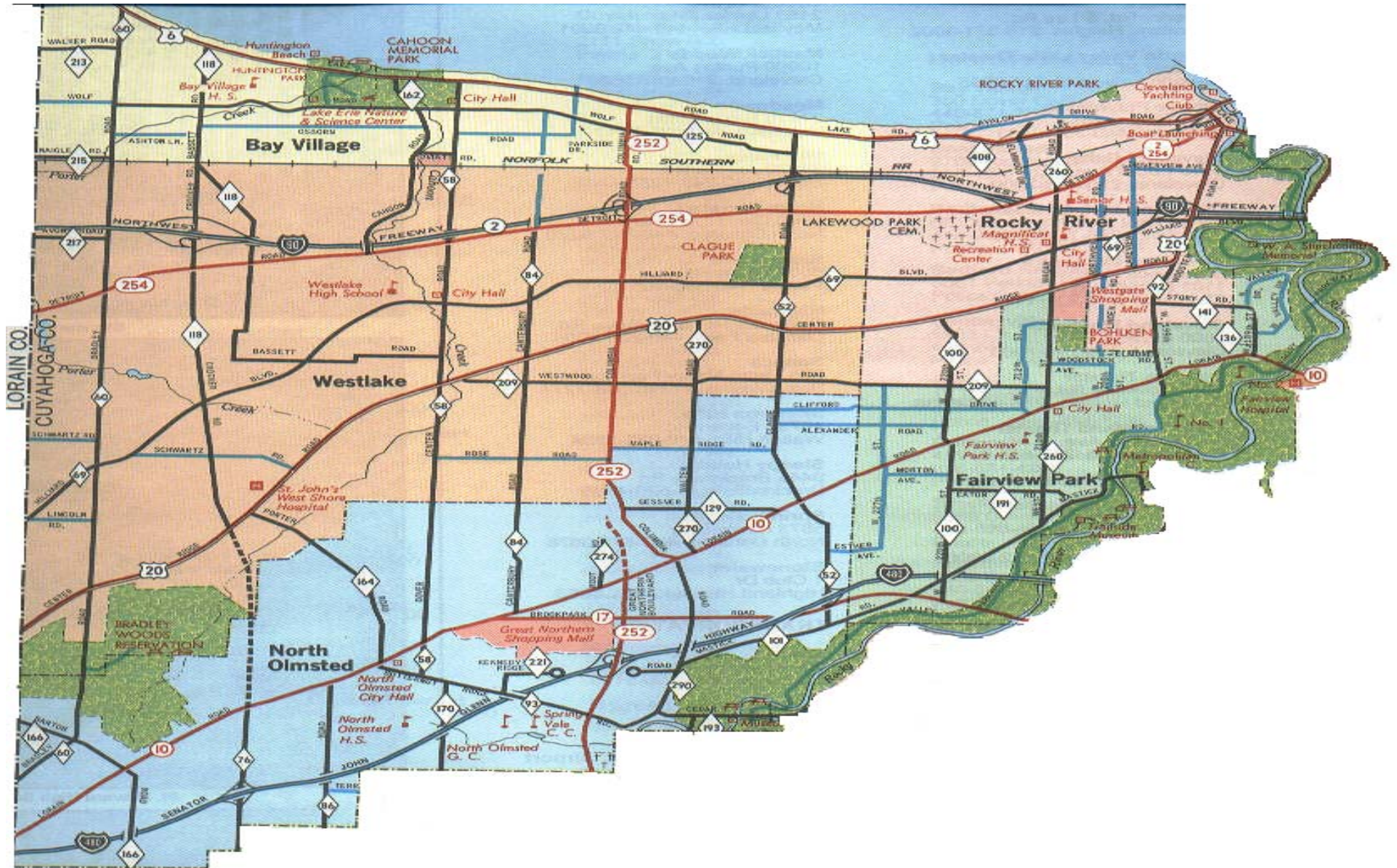

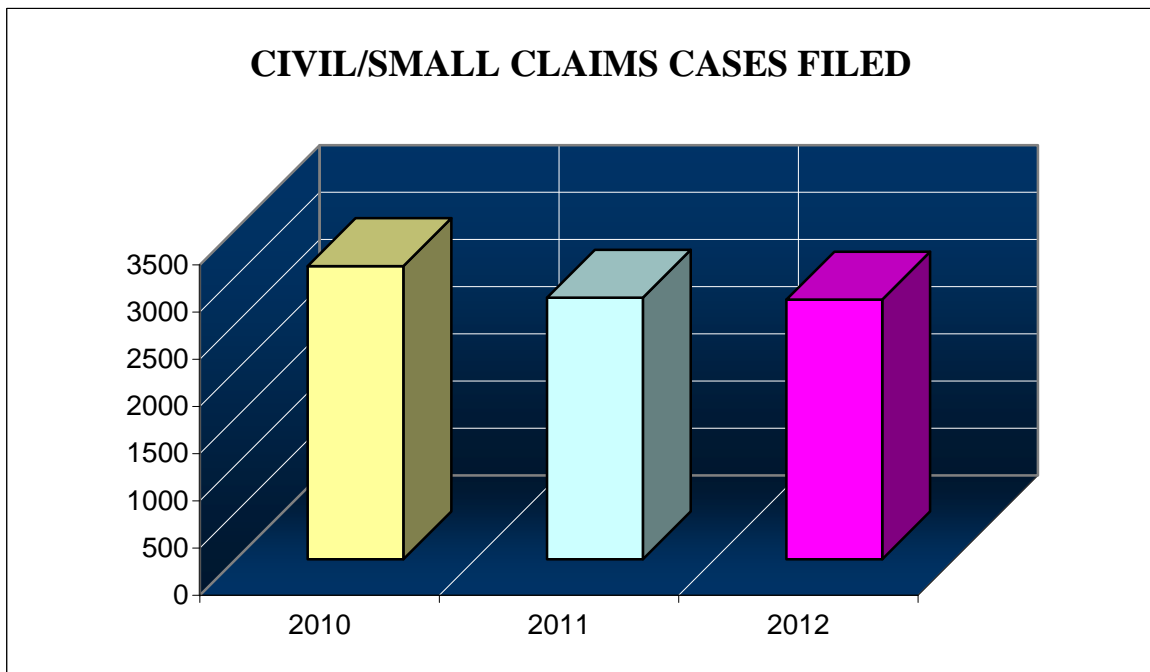
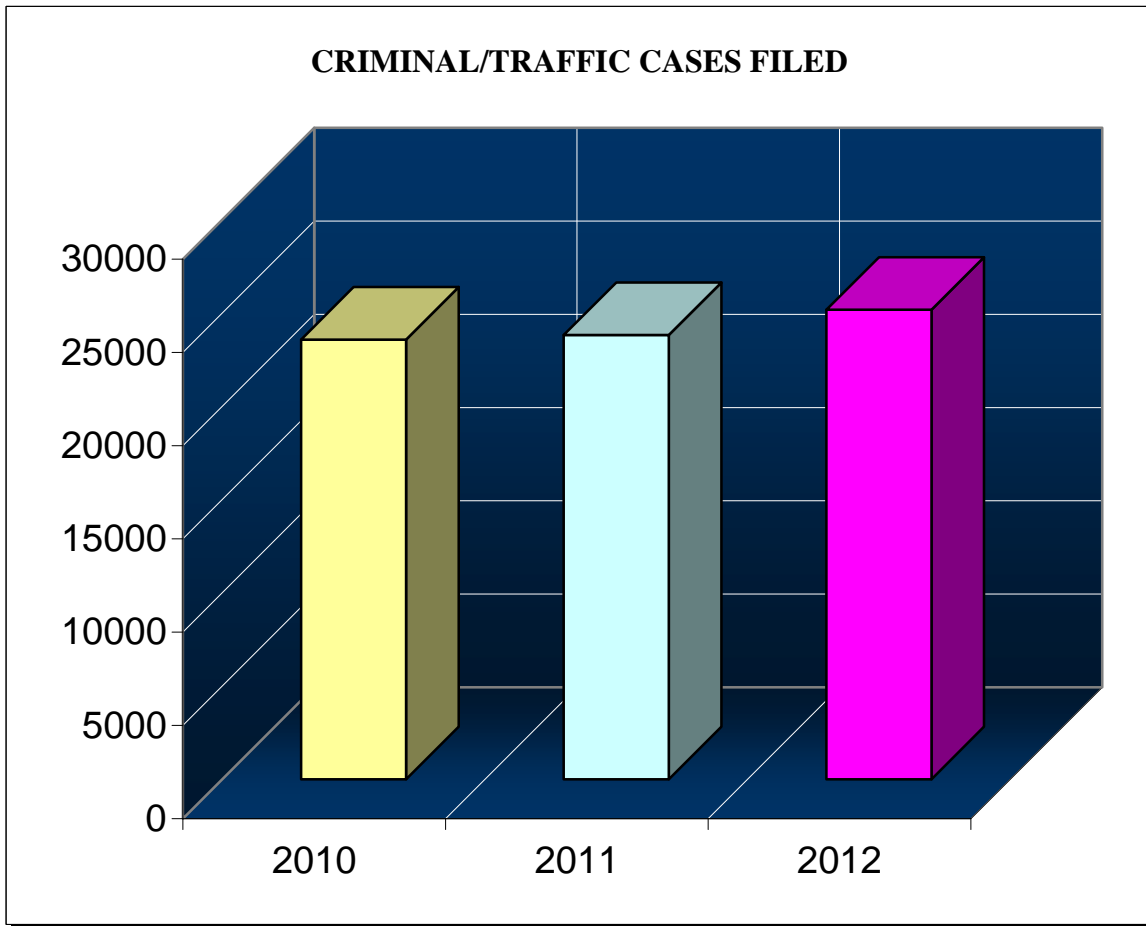

2012 COMMUNITY CONTROL DEPARTMENT OVERVIEW

The Rocky River Municipal Court Community Control Department provides a variety of services to the court and the community. The Department provides assistance to offenders and diversion participants by obtaining services including community mental health, substance abuse, counseling and intervention programs. The Community Control Department monitors offenders to reduce crime and protect the public.

2012 held many challenges. In response to the opiate epidemic, we have used more resources to deal with this serious health crisis. Additionally, with the creation of the North Olmsted Mayor's Court, we have responded by eliminating one position to meet the fiscal changes. In the face of these challenges we have continued to make the Community Control Department supportive of mental health and substance abuse issues in an effort to keep all communities healthy and safe.

The ***Indigent Drivers Alcohol Treatment Fund/ Indigent Drivers Interlock and Monitoring Fund*** provides treatment and monitoring services for persons arrested while operating a vehicle under the influence. The funds come from fees and fines collected as legislated by the Ohio General Assembly. The Rocky River Municipal Court utilizes these funds to assist OVI offenders who are unable to afford substance abuse treatment and alcohol monitoring. In 2012 the Rocky River Municipal Court spent \$95,406.05 for treatment and \$41,006.00 for monitoring.

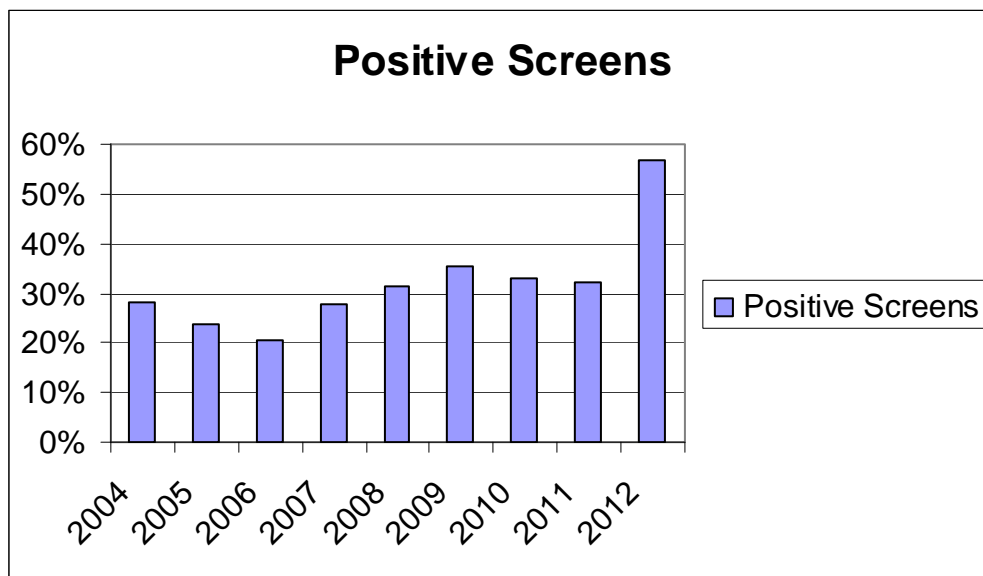

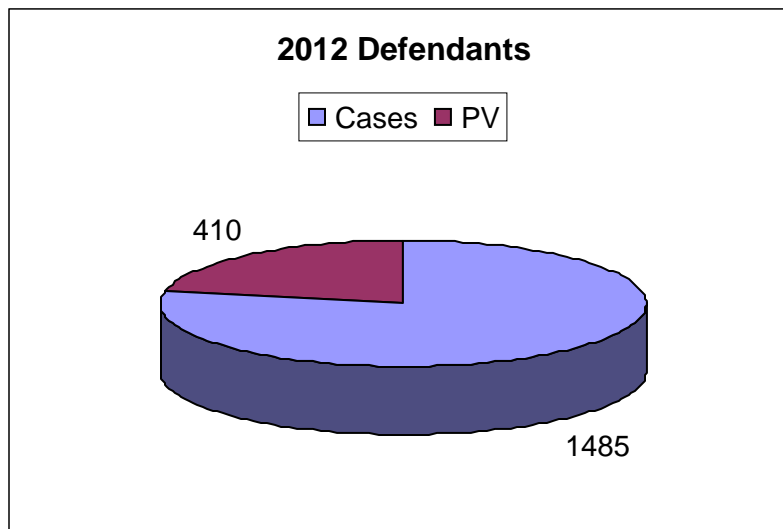

The Mental Health Liaison Project/Byrne Grant has been renewed after a positive history of support since 2002. The primary goal is to decrease the number of mentally ill persons processed through the judicial system by linking them to the appropriate services. Selective Diversion Program

The Rocky River Municipal Court Selective Diversion Program provides a short period of supervision and education for the purpose of assisting offenders in changing the behavior that brought them before the court. Offenders are to complete any counseling, class, or community service that the court finds necessary prior to the dismissal date. Entry into Selective Diversion is through prosecutor recommendation. Included in the Selective Diversion Program is the Theft Diversion Program, a six-month period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders in the Theft Diversion Program are to complete a five-week Theft Intervention Program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.
