Dear Ladies and Gentlemen:

As required by ORC §1901.14, the Annual Report for 2014 is hereby submitted by the Rocky River Municipal Court. The content of this report is based on data assembled and tabulated by Clerk of Court Deborah F. Comery and Court Staff. The following data is noteworthy for the year 2014:

1. There were 13,735 cases filed in criminal/traffic consisting of 10,356 traffic, 503 OVI/BAC, 2,198 misdemeanors, 358 felonies and 319 parking violations. Criminal/traffic case filings decreased by 2,797 cases from 2013.
2. There were 2,391 cases filed in civil and small claims consisting of 1,816 civil, 572 small claims and 3 rent escrow / trusteeship cases. The total civil case filings increased by 203 cases from 2013.
3. The total amount of court costs disbursed to the City of Rocky River from all sources was \$2,380,167.84. Of these monies, \$1,597,421.96 was designated as the Court's operational revenue against operational Court expenditures of \$1,538,640.66. \$202,734.44 was placed in the Computer Fund to operate and enhance the Court's computer system. \$319,661.94 was placed in the Special Projects Fund to continue to pay down the principal and interest debt of the Courthouse structure as well as expensing the salary and benefits of the Court's Magistrates. \$242,952.00 was placed in the Court's Probation Services Fund to assist in the operations of the Community Control Department. \$17,397.50 was placed in the Court's Indigent Drivers Alcohol Treatment (IDAT) Fund to cover court ordered indigent offenders' alcohol assessment and treatment.

RRMC completed its 18th consecutive year without a deficit. An immense thank you to all court staff for their diligence to duty to keep the services provided to all who come to this Court at the highest level of excellence.

4. A portion of the fine money collected in 2014 was placed in two funds established by the State of Ohio and governed by the Ohio Revised Code and are to be utilized by the Court in the monitoring and treatment of indigent drug and alcohol offenders. \$9,988.00 was placed in the IDAT Fund in addition to the cost contribution to the IDAT Fund shown above. \$17,444.50 was placed in the Court's Indigent Drivers Interlock and Alcohol Monitoring (IDIAM) Fund to cover the monitoring of indigent offenders.

The court experienced a 17% decrease in criminal / traffic cases and a 9% increase in civil / small claims cases during 2014. The court has no control over the number of criminal / traffic or civil / small claims cases filed each year.

The Court continues to utilize its video arraignment capabilities to include any video equipped facility within the State of Ohio and beyond. This process saves jurisdictional police departments time and transportation expense along with providing safety benefits to both public and staff within the Courthouse.

Since 2003, our website, www.rrcourt.net, has become an integral part of the Court's public outreach. **eFiling**, **ePayments**, waiver information, public records access, weekly court dockets, local court rules, jury service information, probation information, and these Annual Reports are among the many items found on our website. We continue to accept **ePayments** primarily for those defendants who are allowed to waive their traffic ticket or who choose to pay their fines and costs after their case has been adjudicated. Most of our court documents, both current and historical, continue to be imaged and are available for viewing on the website.


RRMC unveiled its newly revamped **eFiling** system in June, 2014. This new software allows for complete control by the filer to submit **eDocuments** for filing as well as the ability to submit their filing fee payment online. All attorneys are now utilizing our **eFiling** functionality along with a number of frequent filers. Among the upgrades are direct population of data fields within our case management system as well as online payments of civil filings through PayPal. Users can self-register and be filing with a matter of minutes.

With a change to the Civil Rules by the Ohio Supreme Court, 2014 saw a change in the way we serve our documents from **eCertified** to **FedEx Signature Service**. **FedEx** provides a faster, more reliable method to serve court documents to the parties of a case. We have already realized a significant improvement of successful service as well as notice of service and expect that success to continue. All service information including recipient signatures, is downloaded automatically to the individual case docket. Visitors to a case file can track, in almost real time, the progress of all **FedEx** deliveries.

The Clerk's Office continues to provide space for a deputy clerk from the Cuyahoga County Probate Court's Marriage License Bureau. One day a month, residents of Cuyahoga County may apply for a marriage license at Rocky River Municipal Court without having to travel to the downtown Court facility. After participating in this pilot program for two years now, we are one of the busiest locations and have found this to be a successful cooperative effort.

Again, I want to thank the staff of the Clerk's Office for their amazing work and exceptional dedication again this year. I would also like to thank Administrative / Presiding Judge Brian F. Hagan and Judge Donna Congeni Fitzsimmons and their staffs for their help and guidance during the year. Grateful appreciation is also extended to Rocky River Mayor Pamela E. Bobst, Rocky River City Council, and all the Jurisdictional Police Officers and Officials of the Rocky River Court District for their assistance.

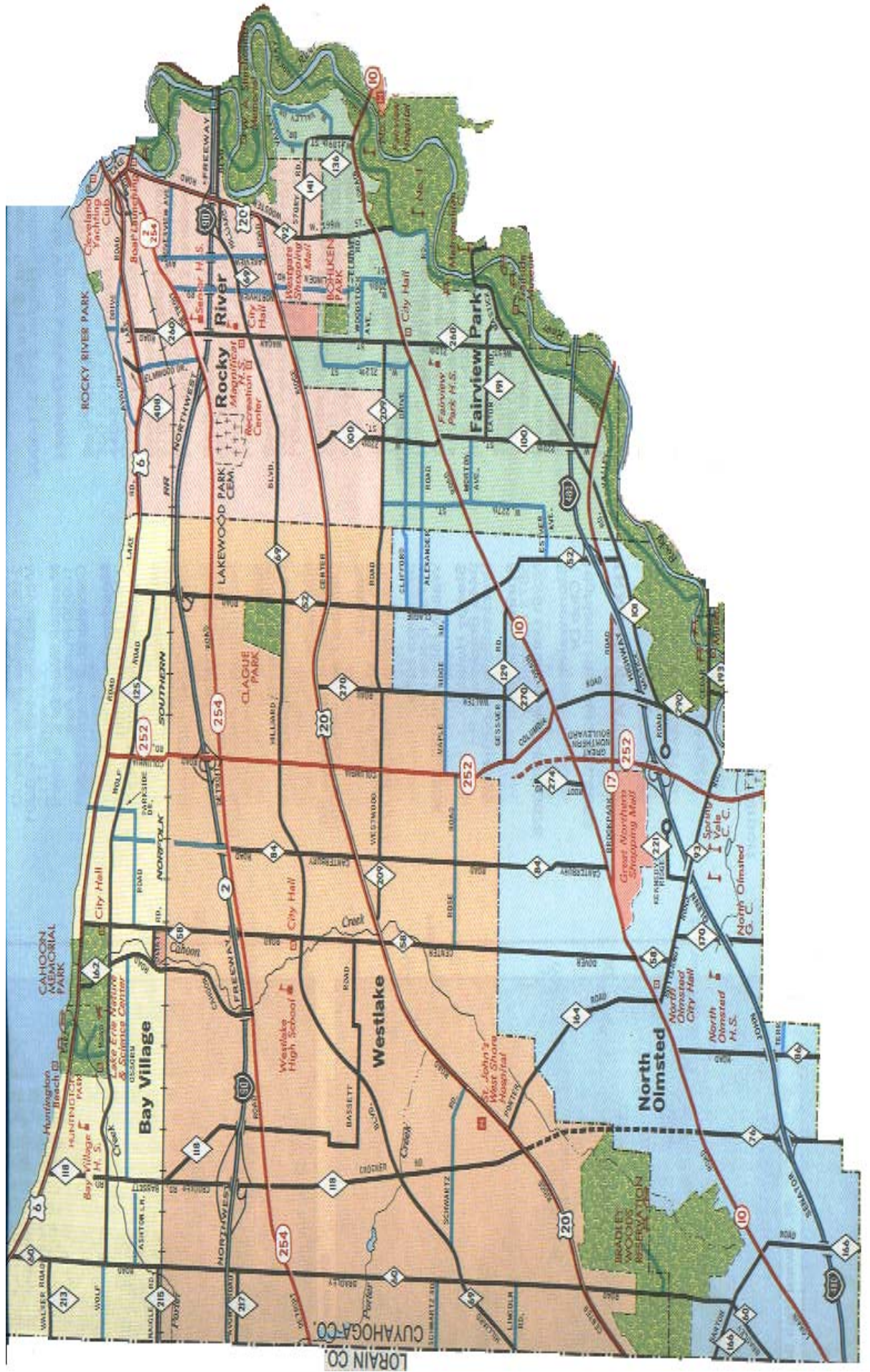

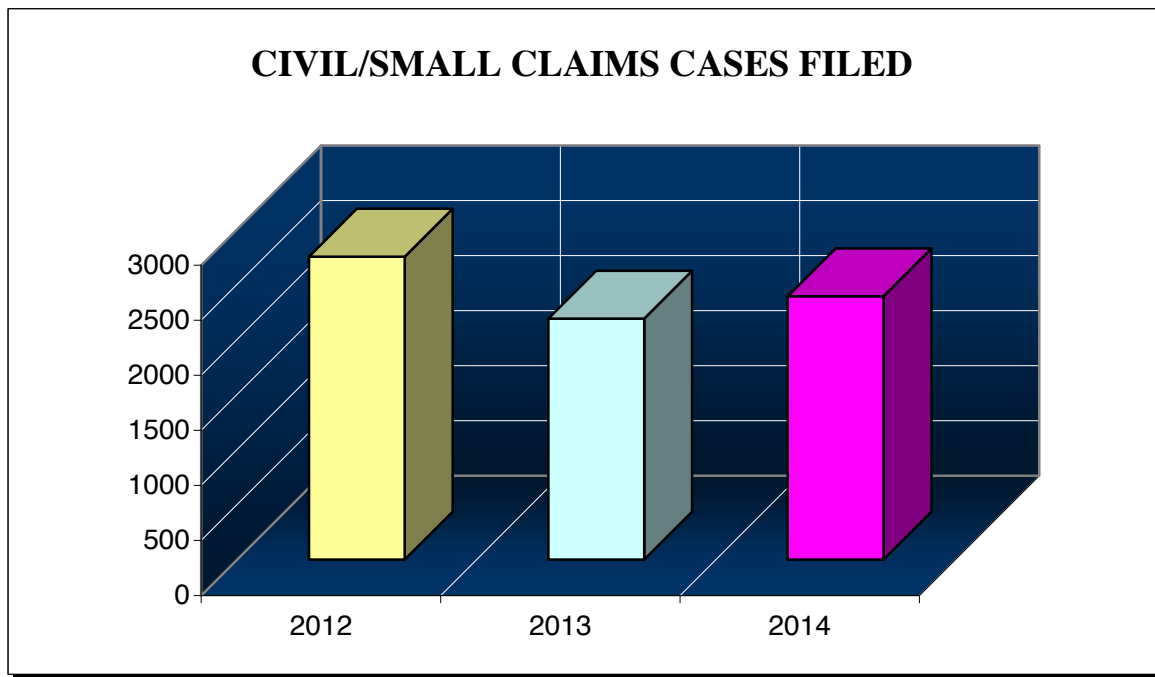
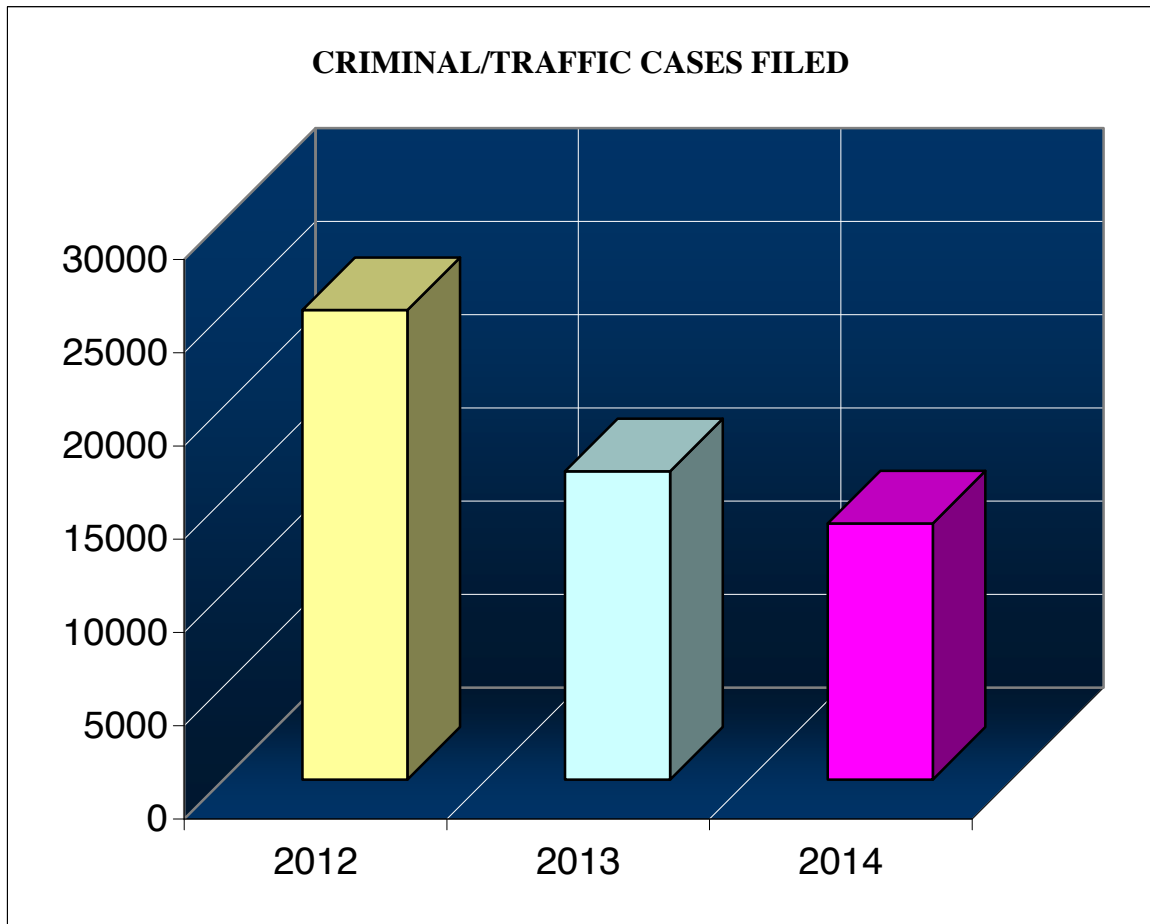

ROCKY RIVER MUNICIPAL COURT

2014 COMMUNITY CONTROL DEPARTMENT OVERVIEW

The Rocky River Municipal Court has been using the Ohio Risk Assessment for most cases over the past 2 years. Recently, the Ohio Risk Assessment has expanded to use the ORAS-MST (a misdemeanor specific screening tool). The Ohio Risk Assessment has been found to be a valid predictor of misdemeanor recidivism. This screening tool helps our judges, magistrates and community control officers use resources for higher risk offenders versus lower risk offenders.

Rocky River Municipal Court has been part the Greater Cleveland Drug Court Suburban Expansion Grant for the past 2 years. In 2014 we referred 32 offenders to the program. The Greater Cleveland Drug Court is committed to assist with intervention, treatment and rehabilitation of non violent drug/alcohol offenders. Also, this year the grant has expanded to utilize medication assisted treatment.

The Oriana Day program has been in place for referrals since November of 2013. In 2014 we referred 37 offenders to the program. The Oriana Day Program provides structured, non residential community corrections programming.

The Community Control Department provides a variety of services to the court and the community. The Department provides assistance to offenders and diversion participants by obtaining services including community mental health, substance abuse, counseling and intervention programs. The Community Control Department monitors offenders to reduce crime and protect the public.

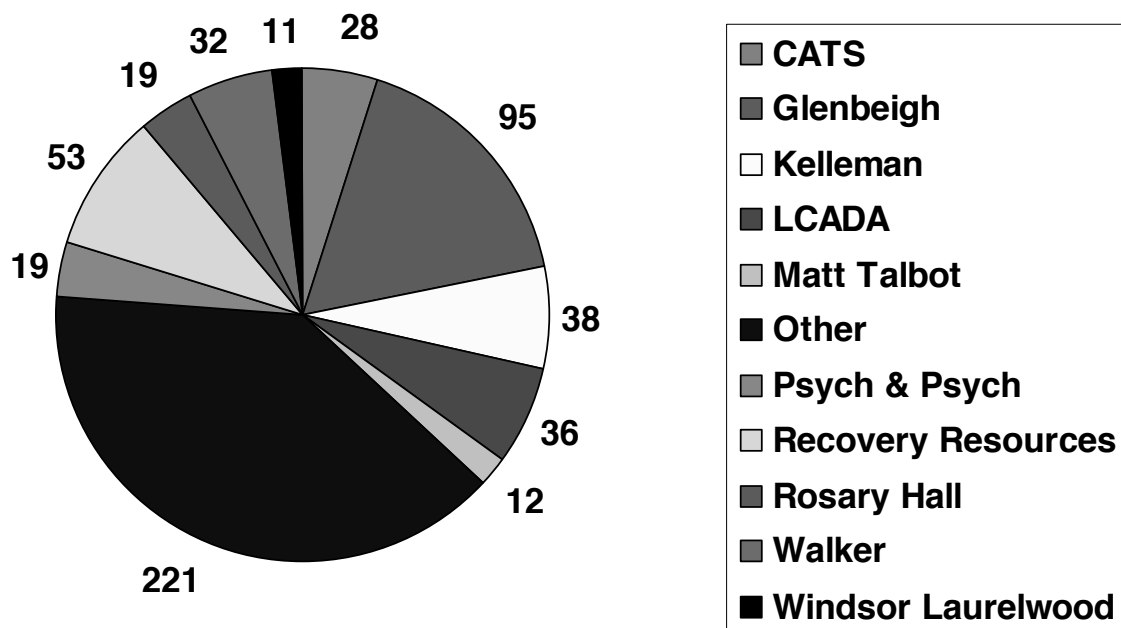

The ***Indigent Drivers Alcohol Treatment Fund/ Indigent Drivers Interlock and Monitoring Fund*** provides treatment and monitoring services for persons arrested while operating a vehicle under the influence. The funds come from fees and fines collected as legislated by the Ohio General Assembly. The Rocky River Municipal Court utilizes these funds to assist OVI offenders who are unable to afford substance abuse treatment and alcohol monitoring. In 2014 the Rocky River Municipal Court spent \$78,565.23 for treatment and \$47,898.00 for monitoring.

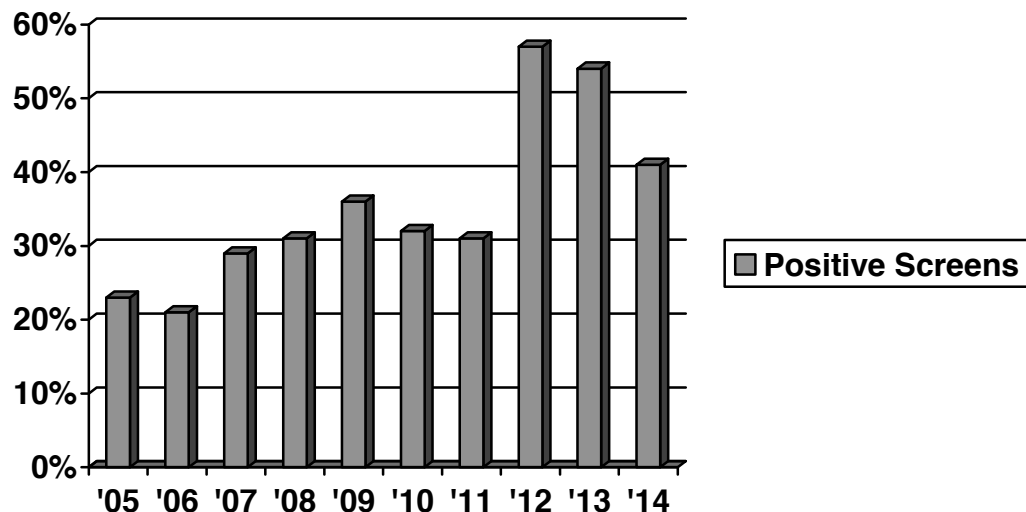

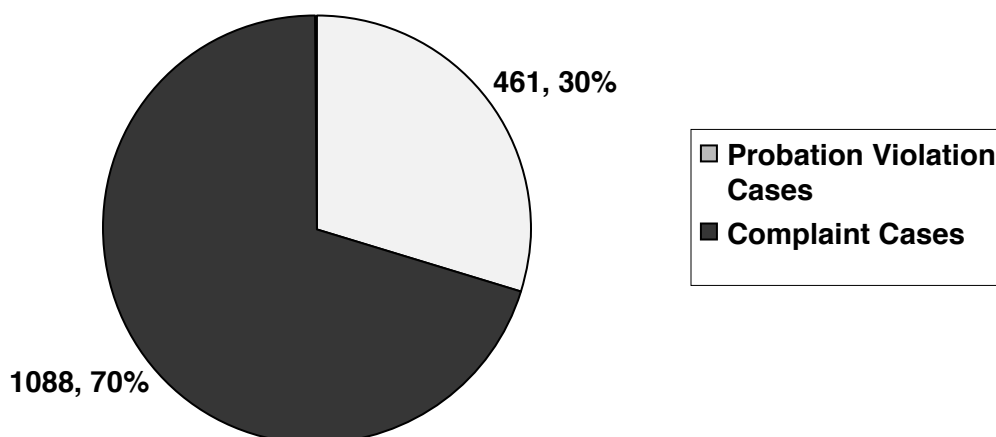

Offenders are required to complete an alcohol education program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.

Selective Diversion Program

The Rocky River Municipal Court Selective Diversion Program provides a short period of supervision and education for the purpose of assisting offenders in changing the behavior that brought them before the court. Offenders are to complete any counseling, class, or community service that the court finds necessary prior to the dismissal date. Entry into Selective Diversion is through prosecutor recommendation. Included in the Selective Diversion Program is the Theft Diversion Program, a six-month period of supervision and education for the purpose of assisting eligible offenders in changing the behavior that brought them before the court. Offenders in the Theft Diversion Program are to complete a five-week Theft Intervention Program, complete at least 20 hours of community service and maintain good behavior for the duration of the program.
